Principal instructed to the Committee to conduct an enquiry and submit Compliance Report in two days i.e., 7/7/2022.

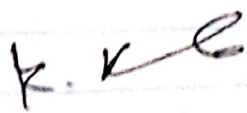

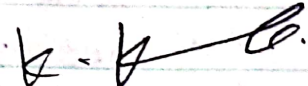

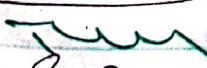
